Mode of Selection for SRF/YP-I

Applications are invited from eligible candidates for **three positions** in various projects, as detailed in the advertisement. These positions are offered on a **temporary, contractual** basis, co-terminus with the respective projects. The initial appointment will be for **one year** or until project completion, whichever is sooner, with **no assurance of renewal**. Appointments may be **terminated at any time** without prior notice or explanation.

Application Process: Interested candidates should complete the application form (Annexure-I). All application materials, including enclosures, must be merged into a **single PDF document** and submitted via email to "rukamsingh.tomar@icar.gov.in" before the deadline. **Separate attachments** or additional documents beyond the single PDF will not be accepted.


Selection Procedure: Candidates will be shortlisted based on the application form. Only shortlisted candidates will be notified via email and invited for an interview, which may be conducted **in-person or online**.

Upon selection, candidates must submit the application in the prescribed format (Annexure-I), along with a **declaration form** (Annexure-II) and **photocopies of original documents**. Any misrepresentation or false claims during screening or at any subsequent stage will result in **immediate disqualification**.

Application Deadline: Applications must be submitted by **25th October 2024 (12:00 midnight)**. Submissions received after this deadline will not be considered. Each applicant should clearly state the **post applied for** and the corresponding **serial number** in the application form. Separate applications must be submitted for each serial number.

Important Note: These positions are strictly **temporary and contractual**, with no opportunity for regular employment at the institute or ICAR after the project's end. The institute reserves the right to **terminate the appointment** at any time, without notice or reason.
